V. Annual Financials and 2023 Budget

Treasurer Jennifer Kultz presented the current years and expenditures, including projected Actuals. The 2023 Budget was APPROVED as presented. The current of \$375 will increase to \$420 for 2023. Refer to QCHOA Proposed Budget for details which can be found on the QCHOA Website.

Details related to Dues Increase:

Insurance Projected increased 10% over PY

Electricity Projected 5% Increase over PY

Landscaping Projected 10% Increase over PY

Water Budget forecast increased watering in 2023

Front Entrance Mulching Increased to 2x a year

VI. Progress on Update of Entrance

Community plans to continue Hand watering front Entrance in 2023. Exploring drip hose system to support volunteer watering.

Mulching will be done twice Annually to help with moisture control as part of the Entrance Landscaping Groundskeeping budget.

Monument Reserve Fund Balance is currently at \$15,000. With the 2023 Dues Collection Monument Reserve Fund will reach goal of \$20,000.

Update on Monument Sign Insert: Sign insert is now Cracked. Board has obtained new bids for new insert from new vendor Sign a Rama for consideration. Bids are for Manufactured Poly material and less Expensive than previous bids. Review in process.

Board has engaged multiple Hardscape companies for submission of bids to repair and improve the Monument. Bids are pending.

VII. Progress on Community Speed Mitigation Effort

In 2022 the Board Engaged King County Roads with a scheduled period installation of a Speed Trailer to address Homeowners Concerns regarding speeding within the community. To recap King County will not allow Speed Bumps or Changing the Speed Limit or Additional Signs. The County will allow speed limit painting on the road. President Michael Brown shared Speed Trailer Data. Speed Trailer results show it as an effective tool in bringing awareness and reducing speeds. The board will continue the Speed Trailer program in 2023.

VIII. **General Association Important Reminders**

- Architectural Control Committee Approvals: Per CCR Section 5.2, ACC approvals are required for proposed building changes. This includes building changes or additions (fence, gate, deck, patio, terrace, wall, kennel, or other structure), as well as lot clearing or excavating. The Board would like to thank those who participated in the ACC submission process this year.
- Owners' Maintenance Responsibilities: Per CCR Section 5.13, each Homeowner shall be obligated to keep his lot, driveways, and parking areas, in a clean, sightly and sanitary condition and maintain their landscaping in a healthy and attractive state and in a manner comparable to that on the other Lots in Quail Creek.
- Trash Receptacles: Per CCR Section 5.7, the trash, recycling, and yard waste containers shall not remain in public view, other than the day of pickup, including the evening before the day of pickup.
- Speed limit is 25 mph in the Community. Please watch speed on Roads.
- Reminder that King the Right of Way to Quail Creek Way and Quail Creek Drive. Landscape materials or other obstructions are subject to removal by the County. The Board would like to thank Homeowners who promptly cleared any landscaping materials or obstructions this past year. The Board has Safety Cones for Homeowners use to mark hazards in the roadway. Please contact the board if you would like the use of safety cones.
